

## DÉJÀ VU CONSIGNMENT & DECOR

**Welcome to Déjà Vu Consignment!** We are excited that you wish to become part of the consignment world!

We understand that at one time you loved the piece you are now consigning, but please note that sometimes there will be items we cannot accept. Please do not take it personally as there are many variables we must take into account when we are accepting items to consign. **All items must be pre-approved before we will accept them.**

### **This is how it works:**

- Photos and condition of all items requesting to be consigned, **MUST** meet our approval before those items can come to the store- no surprise drops to the store are permitted, by appointment only. Email the photo's and dimensions to [dv\\_consignment@outlook.com](mailto:dv_consignment@outlook.com)
- We do not take chipped, broken, badly stained, dirty or damaged goods - if anything arrives requiring cleaning it will not be accepted for consignment. On the scale of 1-10 the condition should rate no lower than an 8.
- It is your responsibility to bring all items to the store and to take them away if they are not sold. Special request drop off and pick up may be negotiable for a fee, with the understanding that Déjà vu is **NOT** liable for any damages during moving or transit etc.
- All linens **MUST** be washed and pressed when brought to the store.
- All lamps must come with shades that are in very nice condition.
- We absolutely do not take upholstered furniture or rugs exposed to heavy smoke or pet hair.
- Items will **NOT** be accepted if they cannot be sold for a minimum of \$10.
- It is in your best interest to itemize your consigning items on the worksheet before you drop them off. Please give us as much information as you can for your item(s) such as description, price you paid, where you bought it and the lowest amount you will accept for the item (optional).

- Glasses – In sets of 4 or more

- Make-up Tables

- Upholstered furniture – no tears, stains, pet hair or smoke odor

- Anything Unique or Funky

## CONSIGNMENT CONTRACT

This contract is the entire agreement between the undersigned consignor and Déjà vu Consignment and will remain in effect for all items consigned.

### CONSIGNMENT TERM

All items are consigned for a term of 90 days beginning when the item is first displayed on the showroom floor. The manner and timing of the display is at the sole discretion of Déjà vu.

Items are consigned for a period of 90 days (3 months) with multiple automatic markdowns during the consignment term.

- After 30 days - a 15% reduction of original price
- After 50 days - a further 10% reduction
- After 70 days - a final 10% reduction

**Please note: Seasonal décor may not be displayed for a full 90 days and will be discounted at our leisure.**

There are no notifications sent by the store indicating that the date of agreement has passed, and the items need to be pick up. It is the consignor's sole responsibility to retrieve any unsold items at the end of the ninety (90) day term. Unsold items must be picked up within 7 days after the expiration date, and during regular business hours. Please email or call us to let us know the date/time you will be picking up your unsold items prior to arrival. **If you do not pick up your items by day 97, they become the property of Déjà Vu Consignment and will be disposed of, sold at a reduced amount, or donated to a local charity. X**

If you wish to reclaim items before the contract period ends, there will be an early termination charge of 10% of the starting price.

### PRICING OF CONSIGNED ITEMS

The consignor will receive fifty-five (55%) percent of item sold based on final selling price, less any sales tax. For items that sell for less than \$50 your portion is 45% of the selling price.

Pricing and discounts are at the **sole discretion of the store**. It is in our mutual best interest to sell your items for the highest price possible. Generally, our policy is to not negotiate the selling price of your consigned items preferring to let the automatic markdowns transpire in their allotted time frames. However, we do reserve the right to negotiate the selling price in good faith on offers made by customers regardless of the automatic markdown time frames.
