

DÉJÀ VU CONSIGNMENT -Fashion Consignment

Welcome to Déjà Vu Consignment! We are excited that you wish to become part of the consignment world! We currently collect Woman's and Juniors Clothing.

We understand that at one time you loved the piece you are now consigning, but please note that sometimes there will be items we cannot accept. We are striving to carry in-trend, high-quality items—meaning anything from name brands like Aldo to high-end fashion.

This is how it works:

- Items accepted on a seasonal basis-Spring/Summer: March-August, Fall/Winter: September-February.
- We accept all sizes of women's clothing, size 0-3X and Petite clothing.
- Vintage is not our specialty, but we do make exceptions for some on-trend pieces.
- All items must be clean and in new-like wearable condition. Articles must be freshly laundered, pressed brought in on hangers (hangers will be returned), accessories in bags. Knits and jeans may be brought in shopping bags or bins. Shoes (no scuffs) and purses clean on the inside and all zippers in working order. Any items clothing presented in garbage bags will be automatically returned to you NO EXCEPTIONS.
- Please review your clothing carefully prior to bringing in your items to consign ensuring there are no stains, holes, pills or odours of any kind.
- When you drop off your items we will collect your contact information. When time permits we may go through items on the spot, but will require further inspection before final approval. We go through your items, judging them based on salability in our boutique.
- Any items that meet our criteria will then be accepted, and processed, and an itemized list with pricing emailed within 7 days. When an item is accepted we set the selling price of the piece.
- The consignor will receive fifty (50%) percent of item sold \$499 and under & sixty (60%) for items \$500 & up based on final selling price, less any sales tax.
- Most items are sold in stores at 25-60% of their retail price with certain exceptions made for items that are either in high demand, new with tags, classic pieces and limited-edition pieces.
- Your items will be sold for 90 days (3 months) selling at regular price for the first 59 days and then reduced to half price from 60 days to the end of your consignment period. Items that retain their value, will not be subject to this discount.
- We occasionally buy items outright and this can be a quick and easy transaction. However, you must notify us at the time of scheduling an appointment that you wish to sell outright. You make less than with consigning, however some people prefer this fast and final transaction. Please note that we are only interested in buying very high-end accessories and designer clothing.

WHAT WE DO NOT SELL:

At this time, Déjà Vu does not consign, buy, or sell men's clothing, children's wear, wedding dresses, lingerie, swimsuits, fur, nor any items from any lower end mall stores or any discount stores. Please keep in mind that we focus on high-end designer labels and boutique items not older than 3 years.

It is against the law to allow counterfeit items to enter the market place knowingly or unknowingly. If you are not absolutely sure your item is authentic, we cannot take it. Original receipts and packaging always help, if you have them.

This contract is the entire agreement between the undersigned consignor and Déjà Vu Consignment and will remain in effect for all items consigned.

CONSIGNMENT TERM

Items are consigned for a period of 90 days (3 months) selling at regular price for the first 59 days and then reduced to half price from 60 days to the end of your consignment period. The manner and timing of the display is at the sole discretion of Déjà vu.

- Most items are sold in stores at 25-60% of their retail price with certain exceptions made for items that are either in high demand, new with tags or classic pieces and limited-edition pieces.

It is the consignor's sole responsibility to retrieve any unsold items at the end of the ninety (90) day term as no notifications are sent by the store. Unsold items must be picked up within 7 days after the expiration date, and during regular business hours. **Please email or call us to let us know the date/time you will be picking up your unsold items prior to arrival. If you do not pick up your items by day 97, they become the property of Déjà Vu Consignment and will be sold at a reduced amount, or donated to a local charity. X**

PRICING OF CONSIGNED ITEMS

The consignor will receive fifty (50%) percent of item sold \$499 and under & sixty (60%) for items \$500 & up based on final selling price, less any sales tax.

Pricing and discounts are at the **sole discretion of the store**. It is in our mutual best interest to sell your items for the highest price possible.

PAYMENTS

The Consignor payment occurs **the 15th of the following month** in which your item is sold. If the amount due to the consignor is less than twenty (\$20) dollars, payment will not be made until the amount due is over twenty dollars, and will be paid with the next pay period.

We will only notify you by email if there is a cheque to be picked up at the store OR we can e-transfer the money to you. We do NOT issue cash payouts. You however have the option to apply your account credit towards any merchandise for sale in the store. If you choose to use money owing to you as a credit and receive 10% off your total purchase before tax.

An administrative fee of \$2.50 will be deducted from each payment. If stop payment of a check is required, a fee of \$35 will be deducted from the net amount due the consigner. **Unclaimed, lost or stale cheques will not be re-issued.**

LIABILITY

Although reasonable care is taken with all merchandise, this is a consignment store where customers are able to handle items, but we are not responsible for damage or loss. Items are left solely at the consignor's risk and without any liability, expressed or implied, to Déjà Vu Consignment.

We do our best to safeguard your items, but our store is also not liable for loss of consigned items due to; fire, theft, natural disasters or any other unforeseen circumstance. X

The consignor warrants that the items were not obtained illegally. X

Déjà Vu has the right to photograph the item(s) being sold and retain the images for use in any materials ie; literature & website features.
